**AN ORDINANCE OF THE CITY OF STANWOOD, WASHINGTON  
AMENDING ORDINANCE NO. 1257 AND ORDINANCE NO. 1285 RELATING  
TO THE 2010 BUDGET.**

**WHEREAS**, the City previously adopted the 2010 budget pursuant to Ordinance 1257;  
and

**WHEREAS**, the City amended the 2010 budget pursuant to Ordinance 1285; and

**WHEREAS**, the City may not by law have expenditures in excess of budgeted  
appropriations for an individual fund;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF STANWOOD DO  
HEREBY ORDAIN AS FOLLOWS:**


Section 1. Ordinance No. 1257 and No. 1285 is hereby amended by amending the 2010


